Councilor (Mr.) Poelstra explained that as per previous meetings, quotes were requested from one local contractor and three contractors from abroad for fabrication of a DOT engineered transition plate design to replace the damaged T-Float transition plate.

Councilor (Mr.) Poelstra contacted the following contractors for quotes, all were sent the same schematic:

A: Crew Enterprises (Ben Crew, local contractor in Edna Bay, AK, notified of local contractor preference)

B: Woolsley Industrial (HDPE.com, Washougal, WA)

C: Pool Engineering (PoolInc.com, Ketchikan, AK)

D: Homestead Skiffs (Ketchikan, AK)

The quotes returned from Woolsley Industrial and Homestead Skiffs are as follows:

A: Woolsley Industrial - \$11,163.33 (quote does not include hinge, or anti-slip coating/plate)

B: Homestead Skiffs - \$8,300.00 (quote includes hinge and fiberglass anti-slip plate)

More questions were asked about Homestead Skiffs quote. Councilor (Mr.) Poelstra noted that if selected, they have quoted a 6-week fabrication window, that the quote includes all items in the DOT schematic they were provided, and Samson is able to easily pickup the plate from their yard and does so regularly.

Consensus of the public attendants was taken in favor of selecting Homestead Skiffs to fabricate

the replacement DOT transition plate. No objections were noted.

Councilor Fairchild moved to accept Homestead Skiffs quote of \$8,300.00 and proceed with purchase of the transition plate.
