Item C – USFS Proposal to Transfer Ownership of New Bridges to City ...:

A letter from the US Forest Service detailing the proposal was projected on the overhead for those in attendance to review.

Mayor Richter explained the requirements for inspection on the bridges. The USFS is willing to provide for the inspections, but all maintenance would be handled by the City of Edna Bay. She suggested adding an exception for construction defects the USFS may have signed off on. Damages noted during the first inspection would also be excluded.
