**A RESOLUTION TO NAME THE CITY OF EDNA BAY AS SOLE APPLICANT FOR
THE DEPARTMENT OF NATURAL RESOURCES ADL 107923, SUCCEEDING
EDNA BAY COMMUNITY, INC. AS THE INITIAL APPLICANT.**

WHEREAS, the Edna Bay Community Inc., a non-profit corporation for the Community of Edna Bay, submitted the original application for public and charitable conveyance to the Division of Mining, Land and Water for the bulk fuel site; and

WHEREAS, on October 03, 2014, Edna Bay incorporated as a second class city; and

WHEREAS, on October 13, 2014, the Edna Bay Community Inc. passed a resolution "to authorize transfer of assets, liabilities and responsibilities to the City of Edna Bay as necessary during the transition period"; and

WHEREAS, the Edna Bay Community, Inc. has passed a resolution (15-05:04-13) stating its withdrawal from the DNR application ADL 107923 for the bulk fuel site parcel; and

WHEREAS, the non-profit corporation is no longer acting in the capacity of the community government; and

WHEREAS, the City of Edna Bay has taken responsibility for the bulk fuel project and site; and

NOW, THEREFORE BE IT RESOLVED that the City of Edna Bay be named sole applicant for the Department of Natural Resource Bulk Fuel Site ADL 107923, succeeding Edna Bay Community, Inc. as the initial applicant.
