Resolution No. 2016-08**

**A RESOLUTION AUTHORIZING THE CITY OF EDNA BAY TO ACQUIRE  
MUNICIPAL ENTITLEMENT LANDS AS PROVIDED FOR IN AS 29.65.030**

WHEREAS, the City of Edna Bay is a recognized second class city, and;

WHEREAS, in accordance with AS 29.65.030 the city is entitled to 10 percent of the maximum total acreage of vacant, unappropriated, unreserved (VUU) state general grant land, within the corporate boundary of the city, and;

WHEREAS, Section VI of ADL #232174 certifies the amount of VUU acreage the city is entitled to under AS 29.65.030 is determined to be 319.561 acres, and;

WHEREAS, Table 'A' (see attachment A) in ADL #232174 identifies the effective VUU acreage for the City of Edna Bay to be 283.61 acres, and;


WHEREAS, the City is selecting all 283.61 acres identified in Table 'A' and Map 1 – State VUU land within Edna Bay (see attachment B), and;

WHEREAS, Mayor Heather Richter is appointed by the City of Edna Bay as its official Municipal Land Selection Agent to act in its behalf in all matter relating to the nomination, selection, or release from selection of State lands, or amendments thereto, and;


NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EDNA BAY, ALASKA THAT: The City of Edna Bay is selecting the entire 283.61 acres of available VUU land, and the mayor is hereby authorized to execute any and all documents required to obtain the Municipal Entitlement Lands identified in paragraph 5. Title shall be held in the name of the City of Edna Bay.
