He noted that there are some things we will be looking into to make Election Day more accommodating for the Judges. One item in particular he will look into with the State is to see if the hours the polling place is open can be reduced down a few hours from the 12 it is currently open.

Mayor Poelstra will be working with DCRA to go over necessary changes to the municipal code for the City to assume ownership and management of the new harbor DOT will start construction on in the Spring. He also noted that the City will need to decide on whether to have a harbor master, what the stall rates will be, and any other final details on management.

He stated that he has not heard anything new from DNR or DOT, other than the document that transfers the new harbor improvements to the City was submitted to DNR, and they have assigned an ADL number to the project.

## **Committee Reports**

#### 7.1 — Dock Committee:

Tyler Poelstra (Dock Chairman) reported that DOT inquired with the contractor who was awarded the new harbor project on whether there were any avenues available to have the breakwater installed this fall. The contractor is firm on their project start window of April 2021.

Tyler noted that basic repairs were completed on the rear gangway pile guide, and stated that he would like to get out and install additional staples to the boom chains and new lashing installed during the last breakwater repair to tighten them up for the winter season. More roofing tiles need to be added to the float plane float, and since it has gotten darker the breakwater light nearest to Brad's house has stopped flashing and will need to be inspected.

#### 7.2 — Road Committee:

Michael Williams had nothing new to report while we wait to develop a rock source, which is being held up by the Municipal Entitlement process being delayed due to legal matters with the State.

Louise DiPaolo had a question on if the City should request contractors ensure they have their equipment in order before the City lets a bid for road work. Mayor Poelstra noted that the contracts have time windows and requirements clearly defined in case someone bids and is awarded work that could not start or complete work in the required time frames. The process accounts for most issues that could be encountered.

Mayor Poelstra noted that further discussion should be held at a Road Committee meeting, and one could be held if needed.

### 7.3 — EMS Committee:

Karen Williams (EMS Administrator) had no report. Mayor Poelstra noted that he had spoke with Chandelle and she is working to get an ETT Online Training template setup for the City to look at in the next few months.

#### 7.4 — Search & Rescue Committee:

No Chairman. Roger DiPaolo reiterated his interested in the position.

#### 7.5 — Fire Committee:

Lee Greif (Fire Chief) no report. Mayor Poelstra reported that repairs on the truck are ongoing.

EMS has looked into this in depth in the past, including plans for where people can go during an emergency, and this item will be discussed on a future agenda.
