Item A - Purchasing Extra Harbor Construction Materials from Western Dock and Bridge (...):

Mayor Poelstra explained that the City has been presented with a last minute opportunity to purchase left over harbor project supplies from Western Dock and Bridge before they depart. These supplies include facia boards, deck boards, structural beams, anchors and anchor chain.

Mayor Poelstra read back a letter from Wester Dock and Bridge itemizing the extra supplies. He suggested that we evaluate the lumber as one unit of purchase, and the anchors and chain as a second due to the cost of each. Consensus was that there is no better time to purchase these items than while they are here. The chain is being sold with an at-cost price to the City (no barge fees added).

Mayor Poelstra suggested that if we have enough chain and anchors it would allow the City to add an additional leg to the breakwater at a later date or possibly set a float if needed.

The total for all lumber supplies: \$4,580.00

Consensus of the public attendants was taken in favor of purchasing the total itemized list of lumber from Western Dock and Bridge, no objections were noted.
